1. You assume responsibility for yourself and your guests, regarding alcohol consumption and behavior; you are responsible for any damage caused to any facilities or items utilized on the club grounds.
2. The discharge of unauthorized firearms is strictly forbidden.
3. If the trap facility is to be used, a member of the trap committee must be present. No alcohol consumption is allowed prior to discharging firearms.
4. You must provide all of your own refreshments.
5. NO motorized vehicles are allowed on club grounds during rentals.
6. You must clean the club grounds prior to leaving that day. ALL cans must be separated and bagged for recycling. ALL trash must be picked up and disposed of in the dumpster. If the dumpster is full notify the vice president.

LEAVE THE CLUB GROUNDS AS GOOD OR BETTER THAN YOU FOUND IT.

7. Reserving the club grounds does not restrict any other member or member's guests from using other facilities on the club grounds except the picnic grove, clubhouse, and the pavilion. If this reservation is taking place after a club event, the grounds are accepted "AS IS". The event chairman will be informed to clean up as soon as possible.
8. This application is subject to Board of Directors approval.
